# Freedom of Information Request Reference No: 01/FOI/22/025946 January 2023

On January 4, 2023, the Metropolitan Police Service (MPS) said it had identified errors in its original response to this Freedom of Information request, and provided revised, correct figures. This document contains the MPS' January 2023 responses. The MPS originally responded to the request on October 7, 2022.

### The Oversight Board asked:

 Details of the Metropolitan Police's policy for making requests to social media and/or streaming companies for such companies to review and/or remove certain of their online content relating to gang violence or serious youth violence on the basis of the content being or suspected to be unlawful. Please include details of the criteria followed by the Metropolitan Police to ensure that such requests reflect the Metropolitan Police's duties to protect human rights, including the right to freedom of expression.

### The Metropolitan Police Service (MPS) said:

No information is held. Each item of such material would be reviewed on a case by case basis and a criminal investigation considered if deemed to be in breach of UK legislation.

## The Oversight Board asked:

2. Details of the Metropolitan Police's policy for flagging to social media and music streaming companies, concerns of the Metropolitan Police formed by itself or in co-operation with other public authorities or agencies on such matters, about online content relating to gang violence of serious youth violence where the underlying content is not alleged to be unlawful. Please include details of the criteria followed by the Metropolitan Police to ensure such indications of concern reflect the Metropolitan Police's duties to protect human rights, including the right to freedom of expression.

### The Metropolitan Police Service said:

No information is held. The MPS use specialist knowledge and expertise to identify harmful content. Officers skilled in this area can provide the necessary understanding of the context and language used in order for platforms to make an

informed decision. The MPS ask social media platforms to take a robust & rapid approach to removing content which is flagged as being harmful i.e. likely to provoke/cause real-life violence.
