Case description

These cases concern two content decisions made by Meta, which the Oversight Board will address together. Both cases involve videos posted on the same Facebook page, described as featuring content about life, culture, and food in Thailand. In the videos, a man interviews a woman about her experience observing a fruit juice-only diet and shares her social media page about the diet at the end of each video.

In the first video, posted in 2022, the woman explains why she only drinks fruit juice, eating nothing solid. According to the woman, she used to suffer from skin problems and swollen legs, which she described as huge and heavy. The woman claims that switching to a fruit juice-only diet has brought her multiple health benefits, including increased mental focus, improved skin, happiness and a "feeling of lightness." After saying that some may comment that this is anorexia, the woman states that dietary changes are often accompanied by sudden weight loss, which explained why she initially lost more than 10 kilograms (22 pounds). The woman states her weight has now "normalized."

In the second video, posted in 2023, the same man asks the same woman, who appears extremely thin, how she feels after observing the fruit juice-only diet for almost a year. The woman laments that she would soon break her fast and eat solid fruit. When asked about her weight, the woman states she has not lost any more weight, but "four kilos of impurities." The woman encourages the man to try the diet. The woman shares that she would now be a "fruitarian" and wants to begin "prana." She describes this as not eating or drinking and instead living "only on energy."

The first post received about 3,000 reactions, about 1,000 comments, and over 200,000 views. The second post received about 8,000 reactions, about 14,000 comments, and over two million views. The Facebook page where both videos were posted has about 130,000 followers.

Both posts were reported multiple times to Meta for violating Meta's Suicide and <u>Self Injury Community Standard</u>. A separate user in each case ultimately

appealed to the Board. These users' initial appeals to Meta to remove the content were immediately closed through automation because prior human reviews had found the content non-violating. The users then appealed the decisions further with Meta, and in both cases human reviewers left the videos on Facebook. In their subsequent appeals to the Board, the users stated that the content promotes an unhealthy lifestyle and may encourage others, especially teenagers, to do the same. They described the content as "inaccurate" and presenting anorexia "as a good thing," which can pose health risks to people exposed to the content.

The Board selected these cases to address how Meta's content policies and enforcement practices address diet, fitness, and eating disorder-related content on Facebook.

The Board would appreciate public comments that address:

- Information about fruit juice-only, fruitarian, and pranic diets, their health impact, and whether these types of diets should be understood as eating disorders.
- Whether Meta's policy on <u>self-injury</u> sufficiently addresses the harms to physical and mental health posed by content that praises or promotes eating disorders.
- How Meta should moderate content relating to eating disorders to protect vulnerable users, including teenagers, while also respecting freedom of expression.
- Information on social media policy and regulatory approaches around the world to address eating disorder, fitness, and diet-related content posted by influential users.
- Insights on the impact of diet and fitness-related content on social media to physical and mental health, particularly of teenagers, globally.

In its decisions, the Board can issue policy recommendations to Meta. While recommendations are not binding, Meta must respond to them within 60 days. As such, the Board welcomes public comments proposing recommendations that are relevant to these cases.
