It is not bullying to state a biological truth. Sex based speech is not harassment, and is a means to describe a factual reality. Sex cannot change, and describing an individual’s sex is a factual descriptive term that allows an audience to understand a factual reality. It provides important context to a situation, especially to inform females about who may be accessing their private spaces where they undress. This is information that may cause a female to re-think how she accesses, or what she does in these formerly private spaces. By censoring and punishing those who are sharing this information is depriving females from having a full set of facts to consider when they are putting themselves into a vulnerable state, in what they think are safe, private, female-only spaces.
