It is not hate to discuss truth, even where that may be uncomfortable or even offensive to some, in fact, a democracy requires it.

Where speech crosses over to actively encourage physical violence, or where the speech simply uses derogatory terms, this should be removed. For example, the terms 'cis' 'tranny' 'terf' 'pig in a wig' should not be allowed & should be removed. However it is essential that reality & truth be allowed. Stating that a man is a man/male is not violence or name-calling, it is a truthful statement of fact, and it is not hateful to state the biological truth of a person or situation so for example, it should not be considered hate when fact is stated such as 'a man/male who identifies as a woman was allowed into the women's category in boxing/a male who identifies as a woman has been transfered to a women's prison despite being sentenced for rape'. These issues have profound consequences for women & it is essential we are allowed to inform the public & have open discussion about these for the benefit of all groups.

So-called 'misgendering' in truth means nothing more than stating reality & to ban this would also have a completely negative impact on the credibility of the platforms concerned. We HAVE to protect the ability to speak freely & truthfully, even where this may offend some people or else there IS no free speech at all."
